Linking Iowa's Freight Transportation System (LIFTS) is a onetime grant opportunity recently announced by Iowa DOT. The program seeks to improve multi-modal freight transportation around the state and economic development opportunities.

ADA Transition Plans

All municipalities are required to comply with the Americans with Disabilities Act, and Title II of the Act has come into greater scrutiny because of Dept of Justice inquiries into ADA compliance. Title II deals with public services and physical accessibility.

Municipalities with over 50 employees are required to develop a transition plan into compliance with ADA, and a common area of non-compliance is curb ramps and accessibility within the right of way. All cities should also consider a transition plan, no matter the size. Recent Grant Awards

SEIRPC has received news of several grant awards, the result of great partnerships and project development. SEIRPC is proud to strengthen southeast lowa by bringing in needed project resources.

SOUTHEASTERN COMMUNITY COLLEGE: \$1,000,000, EDA

SCC received the award to construct its new Industrial Maintenance and Technology building on the Keokuk campus. The new 16,000sf building will house state of the art training modules, equipment, lab and meeting space. Students in industry, trades, manufacturing or other sectors will receive top notch instruction and experience in the new facility.

SEIRPC provided grant writing services and will also administer the grant.

CITY OF BURLINGTON DEPOT: \$480,000, IOWA DOT

The City received the Public Transit Infrastructure (PTIG) grant to rehabilitate the public spaces of the historic depot. Combined with local match funds from the City and Friends of the Depot, the project will make the dilapidated space usable and bring back to life the historic features of the building.

SEIRPC provided grant writing services and process consulting.

SOUTHEAST IOWA REGIONAL PLANNING COMMISSION: \$268,000, IFA

SEIRPC will provide down payment assistance to first-time homebuyers in Burlington through this project. Down payment assistance will be in the form of rehabilitation and closing assistance.
